According to Jere (2019), during the early development stages of the AfCTA, five instruments were launched. This consists of the rules of origin, the online negotiating forum, the monitoring and elimination of non-tariff barriers, a digital payment system and the African Trade Observatory. Don't be alarmed too soon by all these new information! At first, I also didn't fully understand any of them, so you are not alone! We will break each one down for you!

- 1. Rules of origin: Let's dive right into the first instrument! In an attempt to accelerate industrialization in Africa, the rules of origin were created to serve this exact particular purpose. The decree serves as an aid to the AfCTA, to determine which goods are 'truly made' within each African country's border. Goods that meet the minimum requirement will be eligible for preferential tariffs. This simply leads to a creation of more opportunities for smaller businesses whilst, indirectly creating a thriving hub for potential new businesses in the process. Isn't this interesting?
- 2. Online negotiating forum: If you thought the first instrument was interesting then, this will certainly give you a run for your money because, of how fascinating it is! Obviously by now, we all know that Africa is the second largest continent after Asia. Each of the different nations in Africa, already have their own set of trade policies in place, which may differ from one country to another. The online negotiating forum was set up as an intermediary tool, and open-discussion amongst various African nations.
